CONDITIONS OF ENTRY & SALE

1. Each entrant may enter up to seven original, uncopied works, entered on the accompanying official entry form. Avoca Community Arts & Gardens (ACAG) reserves the right at any stage prior to the Exhibition or during the Exhibition to hang or withdraw any work.

2. Artwork must be suitably framed and ready for hanging with a size limit of 1.5m for any side of the work (this includes the frame). Stretched canvas is suitable provided there are adequate cross members. Artwork must be fitted with appropriate and secure devices for hanging/installation such as hanging wire and flush 'D hooks' with no protrusions that could damage of works in transit. Velcro or double sided tape is not acceptable.

3. Each work must be clearly labelled with the artists name & title of the work and attached to the back of the work.

4. Each entrant must complete and sign an entry form & submit with payment.

The entry fee is for handling and is non-refundable.

5. All Artwork displayed is for sale unless explicitly labelled otherwise.

6. ACAG reserves the right to exhibit the entries and offer them for sale at the sale price stated on the entry form. For any sales ACAG shall retain 20% of the sales price as a selling commission.

The sale price includes the Goods & Services Sales Tax (GST)

7. ACAG will not enter into discussion, verbally or in writing, on any judgement.

8. ACAG will exercise all reasonable care in handling submitted works, but will not be responsible for the loss, damage or theft of any works while in its custody or its agents.

It is strongly recommended that artists arrange appropriate insurance for their works.

9. Entries must be delivered free of all charges. No payment will be made by ACAG for freight or other charges incurred delivery or return of the entry.

10. Multiple works from an artist may not be hung together and ACAG reserves the right to place art works in the correct section.

11. Art works in three dimensions, glass, beaten copper, batik, poker work, bark arrangements, plaster relief, unprotected tempera and wet paintings will not be accepted for exhibition in the Art Show.

12. On announcement of the results of the awards, the acquisitive prize winning artwork shall become the property of ACAG

13. ACAG may allow any displayed artwork to be reproduced by print or television for advertising purposes and also reserves the right to reproduce all works exhibited in the Art Show.

15. Any one painting can win only one award.

16. ACAG takes reasonable care to ensure entry form information is correct at the time printing.

17. All prizes are subject to availability of sponsorship.

18. Art work to be received and collected at the venues & times indicated on the entry form. On inquiry by email or phone with the Art Show contacts every endeavour will be made to accommodate alternative arrangements.

Late entries- these may be exhibited but may not be catalogued.

19. If an entrant fails to remove their artwork from the designated address within the nominated time ACAG may sell, retain as its property or otherwise dispose of the artwork after 60 days provided It has taken reasonable steps to notify the entrant including registered post.
